For Class XI

Assessment in Class XI on achievement in scholastic subjects includes Periodic Assessment (50 marks) and Final Term Assessment (50 marks) as detailed below.

For Class XII

Assessment in Class XII on achievement in scholastic subjects and declaration of eligibility for promotion to higher studies are wholly done by the CBSE during February-March as per schedule to be announced by the CBSE. However, internal assessments will be conducted as per the scheme below.



Attendance and Promotion Policy

- A student must put in a minimum of 75 % attendance during the academic year and clear all the arrears of fee and other dues to be eligible to appear in the Board / Annual Examination.
- In case a student is likely to be absent for any test or exam, the parents should seek prior written permission. In case of illness, doctor's certificate must be submitted along with the leave letter. No retest will be conducted for any such reason.
- If a student does not appear at one or more assessments during Term 1 or 2, due to reasons of representing the school in sports, art, music, dance, science, etc., then such absence will be considered on a case by case basis and with a view to encouraging such participation.

- A student who has absented himself from any test / examination will not be considered for any award / prize on overall performance.
- Students joining the school late/mid term shall submit details of attendance, result, etc. from the previous school.
- A student of Class XI will be eligible for promotion only if he/ she secures minimum 33% marks in each scholastic subject and 33% in total aggregate. He / She also have to pass separately in theory and practical exam scoring minimum 33 % marks.
- A student of Class XI failing in only one of the five subjects will be granted compartment in that subject and will have to pass in the Compartment Examination scoring minimum 33% marks.
- A student of Class XI failing in two subjects and more will not be promoted to Class XII.
- The school will issue report cards every term to all students of classes from XI as per policy laid down in this regard by the CBSE.
- In respect of Class XII, passing, compartment, etc. will be decided by the CBSE as per their norms. Currently, the norms are as follows.
 - ✓ A student of Class XII will be declared as Passed by the CBSE only if he/ she secures minimum 33% marks in each scholastic subject and 33% in total aggregate. He / She also have to pass separately in theory and practical exam scoring minimum 33 % marks in each.
 - ✓ A student of Class XII failing in only one of the five subjects will be granted compartment in that subject. Such student will have to pass in the Compartment Examination held by the CBSE by scoring a minimum 33% marks.
 - ✓ A student of Class XII failing in two subjects will not be eligible for compartment. Such student will have to reappear for all subjects in the following March CBSE Examination.
